I'm writing to provide my support for the City of McCammon's Community Development Block Grant application. While this grant will provide amazing benefits for this city, more importantly it will help the local leaders there meet critical needs for their residents.

Due to outdated emergency facilities and equipment, and no on-site ambulance services, residents in McCammon are forced to endure longer than reasonable response times. Statistics from Bannock County for 2020 show an ambulance response time of 21-29 minutes for the 10+ calls per month to the city.

The purpose of the grant is to assist the city in constructing a new fire station. The city's current fire station was constructed in 1974 as a maintenance shed. It is approximately 30'x70' on a lot of 0.19 acres. The city of McCammon is proposing a new fire station of 10,000-12,000 square feet on a 1.5-acre property, already owned by the city, at an estimated cost of \$1.8M. It will contain 4-5 double pull-through bays, along with storage for equipment, a training room and "clean room" for volunteers. The CDBG grant being applied for is worth up to \$500,000 and will be necessary for the city to accomplish the project.

I recognize the important job that you and your team will be undertaking as you review the many requests you'll be receiving for limited funds. I would request added consideration for this application, due to literally life or death circumstances hanging in the balance.

The Idaho Rural Partnership is aware the City of McCammon currently seeks funding for the propose fire station and community center project. My purpose in writing is to document how this project was identified as a priority during the McCammon Community Review. Phase I of the Community Review was conducted in June 2018; Phase II was conducted in October 2018.

We understand the proposed project accomplishes two important goals identified by the community: (1) increasing the community's capacity to provide fire, EMS, and related services and, (2) creating new opportunities for community and recreational activities. The project achieves these goals by constructing a combined fire station/city offices building on land owned by the City located on Center Street and converting the existing city offices on Front Street into a community/senior center.

Phase I of the McCammon Community Review included conducting a survey of residents in McCammon and surrounding area and a series of listening sessions with multiple community stakeholder groups. The survey conducted in the spring of 2018 documented that community residents:

- Are dissatisfied with a current lack of senior support services
- Want new arts, entertainment, and cultural activities
- See a need for more law enforcement presence, especially at night
- Are dissatisfied with existing childcare and other youth activities/services
- Want new facilities and events that bring residents together, regardless of age, religion, and other affiliations

The listening sessions conducted in June 2018 found that:

- A new community center, where all are welcome, was one of the most frequently mentioned community improvements residents want to see. Many listening session participants expressed hope that the desired community center would have space for community events, a kitchen, and possibly other facilities and services such as a swimming pool and fire station. (See report for Phase I of McCammon Community Review, page 26).

- Residents see a need for increased youth and senior services and activities. Listening session participants told us McCammon residents most go to Pocatello for these activities.
- Upgrading equipment, increasing training and volunteer participation, and generally increasing fire and EMS services was identified as a high priority need that residents want to see addressed to better serve McCammon and the Marsh Valley area.
- City leaders informed us the new fire and EMS vehicles can not be obtained because the vehicle bays at the existing fire station are too small.

Completed in October 2018, Phase II of the McCammon Community Review featured project development and action planning activities in response to the goals and needs identified during Phase I. The community identified focus areas for Phase II to help organize planning efforts. The fire station, new fire/EMS vehicles and related equipment was one of the highest priority projects included in the Community Services focus area. This focus area also addressed the related goal of increasing fire and EMS volunteers. Likewise, the goal of developing a community center was among the highest priority projects selected under the Community, Places, and Events focus area.

### **Fire Station Project**

Working Together For a Stronger Rural Idaho

Residents and visiting professionals described the fire station as a "public safety center" as a way to indicate an interest in exploring a facility that could house fire, EMS, and law enforcement (i.e. Bannock County Sheriff's office) services. Project development discussions held during Phase II identified the need to include vehicle bays and a training center in the facility. It was also felt that it should be located in a visible and accessible location. It was felt that completing this project would help increase volunteer participation in the fire/EMS services. (See Phase II of McCammon Community Review report, page 9.)

### **Community Center Project**

Project development and action planning efforts relate to developing a community center during Phase II of the Community Review identified a desire to consider incorporating the following elements in the project:

- Senior center
- Health clinic
- Internet café/coffee shop
- Community meeting space
- Food bank

- Rec. center/gym
- Classrooms
- Farmer market
- Youth center
