SUBJECT: Medical Training Facility

1. The 124th Fighter Wing, Air National Guard, at Boise Air Terminal (Gowen Field) in Idaho requests FY22 Community Project Funding consideration for the requirement to construct an adequately sized (10,550 SF) and properly configured Medical Training Facility to support its assigned training mission and mobilization activities for the wing. The project titled "Medical Training Facility" with project number "BXRH189029" is programmed for \$6,500,000.00. Project design was already funded and the 100% design is complete. The Medical Training Facility is on the FY 2022-2026 FYDP and the FY24 cost estimate is within the programmed amount of \$6.5M. The project was not previously submitted as a request to HASC.
