Dear Chair DeLauro and Ranking Member Granger:

I am requesting \$1,310,459 of funding for the University of Idaho Rinker Rock Creek Ranch project in the FY22 Labor, Health and Human Services, Education, and Related Agencies Appropriations bill.

The project sponsor for this project is the Regents of the University of Idaho located at 875 Perimeter Dr., Moscow, ID 83844 and the project is located near Hailey, Idaho.

The funding is designated to establish University of Idaho education and research training at the Rinker Rock Creek Ranch field station by expanding curricula in rangeland management and animal science. Funding will result in a) hands-on learning for public, postsecondary and K-12 education groups; b) scientific equipment and space for research demonstrations on livestock grazing and sage grouse management, cattle management and wildlife friendly fencing, water quantity and quality conservation, and techniques to combat invasive annual grasses and associated wildfire; and c) upgraded telecommunications systems to facilitate classroom connectivity and research training.

The project is an appropriate use of taxpayer dollars and will enhance workforce training in Idaho by providing opportunities for high school and community college students to pursue postsecondary education. It would also provide demonstration of best practices for integrating working rangelands with conservation interests in the western United States. Few resources have been invested in comprehensive efforts supporting education and public demonstration at the nexus of working rangelands and conservation. Undertaking these efforts on lands adjacent to and managed in conjunction with USDI Bureau of Land Management grazing leases provides a particularly useful laboratory for learning, which at

the University of Idaho spans K-12 education, postsecondary training and adult public education through formal Extension activities.
